Amendment No. 10 to Registration Statement of Form S-1 filed December 8, 2020

General

Exhibit 4.6 stipulates that an investor must submit to the exclusive jurisdiction of state and federal courts located in the City of New York for all legal proceedings arising out of or relating to the common stock warrant. Revise the disclosure in the section captioned "Risk Factors" and in the prospectus to make clear whether this provision applies to actions arising under the Securities Act or the Exchange Act. We note that Section 27 of the Exchange Act creates exclusive federal jurisdiction over all suits brought to enforce any duty or liability created by the Exchange Act or its rules and regulations and Section 22 of the Securities Act creates concurrent jurisdiction for federal and state courts over all suits brought to enforce any duty or liability created by the Securities Act or its rules and Harry Simeonidis GBS Inc. regulations. If this provision applies to Securities Act claims, revise the disclosure in the $\,$

and regulations. If this provision does not apply to actions arising under the Securities $\operatorname{\mathsf{Act}}$
